

Enrollment of Medicaid Members in SNAP and WIC Toolkit


Food insecurity is associated with poorer physical and mental health, a higher incidence of chronic disease, and higher healthcare costs.^{1,2} Households with children as well as households headed by Black, Hispanic, and single parents are more likely to experience food insecurity than their counterparts.³

The Supplemental Nutrition Assistance Program (SNAP) is the first line of defense to address food insecurity. Families enrolled in SNAP receive money on an EBT card to purchase food. Children on SNAP automatically qualify for free school meals and additional funds when school is not in session (P-EBT). Medicaid Members (MM) are at high risk for food insecurity and the majority are eligible for SNAP.

The Supplemental Nutrition Assistance Program for Women, Infants, and Children (WIC) provides funds on an EBT card for nutritious food for pregnant and breastfeeding women and children younger than 5 years of age. Breastfeeding support and nutrition education is also provided. All MMs are financially eligible for WIC.

Both SNAP and WIC have been demonstrated to improve food and economic security, advance health and educational outcomes, and reduce health costs.^{4,5,6,7} Unfortunately in Colorado, fewer than 50 percent of eligible MMs are currently enrolled in WIC or SNAP.⁸

Physicians and healthcare staff can leverage their relationships and touchpoints with MMs to promote the health benefits of the WIC and SNAP programs, ask if families are enrolled, and assist with program enrollment.



Options to Assist with SNAP and WIC Promotion & Enrollment

Promoting the health benefits of SNAP and WIC together with enrollment assistance will yield greatest impact. The options listed below can be utilized by your health organization to effectively promote the programs and assist patients with SNAP and WIC enrollment.

Quality Improvement

IDENTIFY THE TEAM: Designate a project champion and team. Plan for regular team meetings to generate ideas, review data, share learning, and celebrate successes.

DEFINE THE OPPORTUNITIES TO INCREASE SNAP AND WIC ENROLLMENT: Analyze your existing organization and determine what actions may increase enrollment outcomes. **ESTABLISH MEASURES:** Determine how you will evaluate whether changes to your existing system result in improvement. Example measures might include:

- # (or %) of MMs asked about SNAP/WIC enrollment
- # (or %) of MMs referred for enrollment assistance
- # (or %) of MMs for whom SNAP/WIC enrollment is completed
- % Patients satisfied with the enrollment processes

DETERMINE THE LEVERS AND GENERATE IDEAS: Consider the leverage points in your existing enrollment system. Formulate and prioritize opportunities for impactful change.
SET YOUR GOALS: Determine an initial testing aim and timeline (e.g., of the XX% of MMs seeking care at our office, we aim to improve enrollment completion from A% to B% by Z date).
TEST CHANGES: Use iterative Plan, Do, Study, Act (PDSA) cycles to test small-scale changes. If possible, establish baseline value(s) for each measure and then begin tracking your referral and enrollment data. Based on your data, decide whether to adapt, adopt, or abandon each idea.
